This deed of Public Charitable Trust of **YOUTH WELFARE FOUNDATION** is declared on this 21<sup>ST</sup> day of March 2022, by Mr. Azad son of Shree Raju, presently residing at B -139 2<sup>ND</sup> Floor G D Colony Mayur Vihar Phase- 3 East Delhi- 110096 (PAN: EAWPA2566R). hereinafter called the 'SETTLOR' which expression unless repugnant to the context or meaning thereof deemed to include the survivors his/her heirs, executors and assigns.

AND WHEREAS the additional TRUSTEE shall be:

2. Mr. Sachin Kumar, son of Shree, Naresh Kumar, residing at B - 139, 2<sup>ND</sup> Floor G D Colony Mayur Vihar Phase - 3 East Delhi - 110096 (PAN: EPZPK8235M).

WHEREAS THE SETTLOR is desirous of creating a Public Charitable Trust and whereas in pursuance of this desire, has this day created a Public Charitable Trust, under this instrument detailing herein the objects of the Trust, its powers, the manner in which the Trust is to function and other such details as are necessary for the power functioning of the Trust.

NOW THIS INDENTURE WITNESSES AS FOLLOWS:
